I understand that I am consenting to these policies and procedures as a student of Sing Voice Studios and (or) as a parent or guardian of a student of Sing Voice Studios.

By signing below, you agree to the following policies and procedures. You understand that if any Sing Voice Studios policies are not adhered to, you may, at Sing Voice Studios' discretion, be dismissed from the studio.

Private and Group Tuition

I UNDERSTAND that tuition for full-time students is \$140.00 per month. This includes three half-hour private lessons and one hour performance class per month. In the event of a 5th week, an extra private lesson will not be held. I also understand that if I am a part-time student, tuition is \$80.00 per month. This includes two monthly half-hour private lessons and one performance class per quarter. I understand that group lesson tuition is \$75.00 for SINGKids and \$85.00 for SING-Glee and SINGAdults per month for 50 minute sessions.

Automatic Tuition Payments

I UNDERSTAND that tuition is paid monthly on the 25th for the coming month through an automatic withdrawal from my credit card or checking account. In the event of an insufficient fund return, I authorize SING Voice Studios to debit my bank account/credit card for the insufficient funds plus a \$25.00 NSF fee.

30-Day Termination Notice

I UNDERSTAND I am able to discontinue lessons with a 30-day written notice (E-mail works). I also understand that after giving 30-day notice I am responsible to attend the remaining scheduled lessons or lose the unused prepaid tuition. This means I will make a full effort to attend remaining lessons and

that no refunds will be given for missed lessons.

Attendance and Missed Lessons

I AGREE to make every effort to attend all lessons. I understand that I must give at least 24 hours' notice if I am unable to attend. Otherwise I forfeit the lesson without options for a make-up lesson. I understand that while the instructor commits in good faith to make a sincere effort to reschedule lessons, make-up lessons will be scheduled at the instructor's convenience and availability, are not guaranteed, and will not be carried over longer than one month from the date of the missed lesson. In the event that there is no availability, any missed lesson will be forfeited. No make-up lessons are available for a missed group or performance class.

Tardiness

I UNDERSTAND that if I am tardy for lessons, my lesson will still end on time. I understand that I should arrive at least 5 minutes early to avoid this. I understand that as long as I am on time, my lesson allotment time will never suffer, and if the instructor is behind, and thus begins my lesson late, my lesson will still last thirty minutes.

Holidays

I UNDERSTAND lessons will not be taught on Christmas Day, New Year's Day, Thanksgiving Day, Memorial Day, Labor Day, or July 4th and 24th holidays unless scheduled with my instructor. I understand that if my lesson falls on these days or other school breaks, I must reschedule my lesson and that my instructor will make every effort to accommodate me.

Release of Liability
